Dear All

Amathus Beach Hotel Limassol is a 5 star luxury hotel that is overlooking a blue flag beach, has impressive indoor and outdoor pools, excellent spa, 3 bars and 5 restaurants.

All rooms are air-conditioned and comprise a private bathroom with a shower or a bathtub and a hairdryer. Each features a TV and a minibar.

For those of you who still have not booked, please do so as soon as it is possible for you, as the number of rooms we reserved in block is limited. For your convenience, the Hotel Booking Form is attached below.

The Hotel is 8.5 km away from the Limassol city centre and about 55 km away from Larnaca Airport, which is the closest airport. Depending of the traffic density, taxi ride from Larnaca Airport to Amathus Beach Hotel Limassol will cost approximately 55 EUR. Taxi ride lasts approximately 40 minutes, again depending of the traffic conditions. There is also and a bus line – ticket is in range between 6 and 8 EUR (one direction), however, the ride in average lasts a bit more than 2.5 hours.



MARIOS TANNOUSIS

Marios Tannousis holds the post of Deputy Director General at the Cyprus Investment Promotion Agency (CIPA). He has more than twenty four years of international corporate experience, with twelve years in the international banking and financial services group Societe Generale, where he served at various key posts.

He is a Member of the Board of the European Fund and Asset Management Association (EFAMA) as well as the Cyprus Investment Funds Association (CIFA). He also served as President of the Cyprus Finance & Leasing Association and Board Member in various other organizations and bodies.

He is a Member of the Chartered Institute for Securities and Investment (CISI) and holds a Bachelor's degree in Economics from Rutgers University, NJ, USA and an MBA from Mankato State University (MSU), MN, USA.

He is also Certified for offering investment services and has a special interest in Economic Development through Investments especially in Banking, Financial Services and Investment Funds. He represents Cyprus in various international and European Conferences.

HARRIS C. GEORGIADES

Harris Georgiades is Chairman of the Foreign and European Affairs Committee of the Cyprus Parliament and Deputy Leader of the Democratic Rally Party. He served as Minister of Finance of the Republic of Cyprus between April 2013 - December 2019.

He was born in 1972 in Nicosia and holds a BA and an MA in International Relations and Economics from the University of Reading, UK. Between 1999-2011 he was managing director of a family-owned hotel business.

In 2011 he was elected to the Cyprus House of Representatives with the Democratic Rally Party (a member of the centre-right European Peoples Party).

He was appointed Minister of Finance in 2013, at the height of a severe financial crisis. He was successful in restoring the soundness of the Cyprus economy, placing it in a path of solid economic growth, surplus budgets, rating upgrades and banking sector restructuring.

He was a long-serving member of the Eurogroup and the ECOFIN and was elected Chairman of the Board of Governors the European Bank for Reconstruction and Development for the period 2014-2015. In 2016 he was selected by POLITICO as one of 28 influential Europeans and in 2019 was Chair of the Summit of Commonwealth Finance Ministers.

In January 2020 he was elected as Deputy Leader of the Democratic Rally Party and in May 2021 was re-elected to the House of Representatives.
